CIIr Neary welcomes name change of new park at Marina Village

Social Democrats Cllr for Greystones, Delgany, Kilcoole and Newcastle has welcomed the change of name of the new park by the Marina Village in Greystones. Currently, the official name of the new park is Coastal Linear Park however, the area before it was development was colloquially known as 'Darcy's Field'.

Cllr Neary says "After speaking with members of the public a number of months ago I realised there was no colloquial or agreed name for the new park at the Marina. I thought this was something that could be addressed by proposing to the Council that a new agreed name be assigned.

"While I wanted the name change to go out to public consultation particularly with local secondary schools, it was agreed that due to the cumbersome nature of public consultations and the need to act quickly ahead of new signage being developed for the park it was unanimously agreed that Councillors would decide on the new name

"Several names were suggested including Marina or Harbour Park, Jubilee and Castle Park, but we settled on Darcy's Field due to the history of the site which used to be a field and was used by football clubs as well as a popular hangout for young people back in the day

"It was suggested that this name would unite past associations with the site for residents who have been here a longer time, and new residents in the area including at Marina Village. It will also help to mark a new relationship with the area which has had a contentious history, one I hope marks a positive future" concluded Cllr Neary.

Council makes funding commitment for feasibility study for West Wicklow swimming pool

Social Democrats TD Jennifer Whitmore has welcomed the publication of Wicklow County Councils' Capital Plan which has listed as a priority a pool for West Wicklow and committed to €50,000 towards a feasibility study for the project.

The Capital Plan includes a list of large-scale infrastructural projects to be prioritised for the next three years, if and when funding is made available.

Deputy Whitmore welcomes the development

saying "The Capital Plan has designated the pool for west Wicklow a priority project depending on the availability of funding. The Plan also commits to €50k towards a feasibility study in conjunction with the Pool for West Wicklow Committee, and will further progress this much needed project.



Harris seeks Social Audit of Delgany after An Bord Pleanala decision

Wicklow Fine Gael Minister Simon Harris TD has expressed his disappointment with the decision issued by An Bord Pleanala in respect of the new housing scheme proposed for the grounds of the Carmelite Convent in Delgany.

Minister Harris said "I am disappointed that this decision did not address issues we all constructively raised around our public services, local infrastructure, school places, etc. We all appreciate the need for housing. We were attempting to constructively engage to ensure this was gotten right

The Minister added "I now intend to do everything I can to assist in making sure the key issues we highlighted are addressed in terms of school places, traffic, playground and community facilities, etc.

"In light of An Bord Pleanala's decision I have written to the Chief Executive of Wicklow County

Council requesting a Social Audit be carried out in Delgany concerning the additional needs imposed on the community for School Places, Public Transport, Road Infrastructure and amenities.

"In view of the work underway to prepare the County Development Plan I have asked the Chief Executive to meet me urgently on this. It is anticipated that the first draft of the County Development Plan will be published next month and there will be an opportunity by members of the public to make submis-

Calls for Council to apply to OPW for funding of temporary flood relief measures at The Breaches

Minister Simon Harris TD has called upon Wicklow County Council to apply to the Office of Public Works (OPW) for funding for temporary flood relief measures at the Breaches in Kilcoole and Newcastle.

Minister Harris said "There has been a number of near misses in recent weeks as regards blockages at the Breaches and the possibility of local homes being flooded.

This week I met with my colleague the Minister for Public Works regarding the need for the OPW to fund temporary flood prevention works to keep the Breaches clear until a long term flood defence scheme can be put in place.

"The prevailing easterly winds over the past

month has made the task of keeping The Breaches clear exceptionally difficult. I would like to thank Irish Rail and the Owner of Newcastle Aerodrome for the works they undertook to clear the blockages and prevent local homes being flooded.

"The OPW recently appointed an Engineering Consultant to examine a viable long-term flood defence scheme for the Breaches. While this is welcome, this examination will not be complete until the summer.

"In the meantime, I have requested a meeting with the CEO of Wicklow County Council and asked that the County Council apply to the OPW for funding towards temporary ongoing remedial works to keep The Breaches clear until such time as a permanent flood defence is in

Cliff walk closed after landslide

a number of landslides as the cliff has become unstable in parts due to the prolonged period of very heavy rainfall on top of the very wet preceding months of January and February. Some of the landslides are visible from the walk but others are not and are considered dangerous as those using the walk would not be aware of same.

Local brothers start petition to rewild National Park

A petition to rewild Wicklow Mountains has been shared widely on aspects of this proposed so far attracted almost 6,000 supporters in just a few weeks. It was started by brothers Danny, Simon and Ian Alvey originally of Wicklow Town.

It is in response to a press release from Fáilte Ireland in conjunction with the Office of Public Works (OPW), National Wildlife Parks and Service (NPWS) and Coillte along with the National Monuments Service and Wicklow County Council on a Masterplan for the park

"Rewilding the world around us by restoring habitats and improving biodiversity is an urgent and topical issue in the face of twin climate and biodiversity crises," said Danny from his home in Newtownmountkennedy.
"My brothers and I

have spent our lives hiking and walking in Wicklow and can see how wildlife has been in decline. When we heard about a proposed masterplan for the park we were disappointed to see no mention of addressing this issue but rather a focus on the 'visitor experience' by building more car parks, roads and walking trails. Anyone who regularly visits the Wicklow Mountains, will agree it is a National Park in name only, instead the landscape is dominated by Sitka spruce plantations that are regularly clear felled for commercial gain. Anyone who

walks through the deathly silence of one of these monoculture woods will know that these plantations do not contribute to biodiversity or the 'visitor experience'.'

The petition calls on

the Minister of State for Heritage, Malcolm Noonan, to prioritise the removal of Sitka spruce plantations from within the protected boundaries of the park and the restoration of native woodland and other native habitats. It has

Older brother Simon, now living in Rathdrum, said: "During lockdown everyone has been walking and exercising outside much more and last year visitor numbers to the National Park increased considerably. Anyone who travels from one end of the park to the other will know there is no true wilderness left and we need to change this by creating and growing a zone for native woodland and other habitats in the centre. We welcome other

An introduction to the Codling Wind Park project



Dear community members,

I would like to begin by introducing myself. My name is Arno Verbeek and I am Project Director for the Codling Wind Park project, a proposed offshore wind farm approximately 13km off the coast of Wicklow, between Greystones and Wicklow Town.

Codling Wind Park could provide enough locally-produced, low-cost renewable electricity to power the equivalent of up to 1.2 million Irish homes. This will make a significant contribution to the Irish Government's commitment to generating 70 per cent of Ireland's electricity from renewable energy by 2030. It will also go a long way towards enhancing Ireland's energy security, by reducing our dependence on imported energy.

Together with an excellent team of 40 people with expertise across a range of technical, environmental and social disciplines, we are currently in the early stages of planning what could be Ireland's flagship offshore wind project. Throughout 2021 we will be undertaking a range of site investigation works and offshore surveys to help us prepare an environmental impact assessment of the proposed project. This will be in preparation for a planning application, which we hope to submit at the end of this year or early next year.

"It is important to us that you, the local communities, are involved in the project and help us to shape it."

As we progress this work, we will be engaging regularly and openly with local communities and providing several opportunities for you to view our plans and provide feedback. I am writing this letter to you today to make you aware that the first of these opportunities is about to begin.

For a four-week period starting on Monday, March 1, you will be able to learn more about the project, ask

questions and provide your feedback to us, which is most important. Below you will find specific details on the timings and ways of accessing this engagement and consultation process.

Though nationally significant, Codling Wind Park will also be a local project and it is important to us that you, the local communities, are involved in it and help us to shape it.

This is the first of many opportunities you will have to see how our project is progressing and to share your feedback with us. As Covid-19 restrictions ease in the months ahead, we hope to return to face-to-face meetings and to also have physical exhibitions at a range of local venues. I look forward to meeting with many of you as part of these future engagements.

Codling Wind Park is at the start of its journey. I hope you will be part of this journey with us so that together we can create something that benefits Wicklow and Ireland for generations to come.

Observation on West Wicklow wind farm application submitted

Social Democrats TD Jennifer Whitmore has submitted an observation to Wicklow County Council highlighting concerns in relation to an application for the development of a wind farm in West Wicklow. ABO Wind has submitted a planning application to develop a number of wind turbines near Baltinglass affecting the townlands of Kilranelagh, Colvinstown Upper and Boleycarrigeen.

Deputy Whitmore outlined in her submission:

'The archaeological quality of the area is vulnerable to large scale development and can be compromised. Kilranelagh Hill is an integral part of one of Ireland's most unique and ancient landscapes, the Baltinglass Hillfort Complex. Given the reference to this area in the County Development Plan, the potential for further excavation and other archaeological finds as well as the lack of suffi-

Hillfort Complex as a whole, I believe much greater consideration of this context must be given by the Council.

"There are also broader environmental and ecological concerns associated with this type of development. Kilranelagh is a refuge for flora and fauna and in close proximity to numerous of rivers and streams. According to local community groups and residents, buzzards and peregrines are a daily sight over Kilranelagh and curlews have nested cient reference to the there recently. I would

have concerns that if development is not carried out sustainably with the full environmental impact considered, this could have negative impacts on the archaeological value of the area.

"Furthermore, potential for sustainable tourism as well as educational and economic benefits from the archaeological value of Hill Fort area (including Kilranelagh) has not been fully appreciated to date. In absence of this I would urge the Council to proceed with caution in relation to this development until the full poten tial of the area has been considered and until it has been confirmed that any large- scale development would not compromise the culture heritage this area.'

All the graves will now have to be pho tographed & all the details logged onto irish-graveyards.ie. When that is complete all the information will go live in order to allow people make any alterations.

Then in the coming months the company will supply the council with signs and maps to be erected in the cemetery.

It is believed that the survey will commence as soon as the current restrictions are eased. Members of the public can visit the Irish Graveyards website, type in the name of the person they are looking for and all the details of that person will be found including dates, plot, section, and a photograph of the grave.

Public consultation on Codling Wind Park opened

The first phase of public consultation on the Codling Wind Park project - a proposed offshore wind farm approximately 13 kilometres off the Wicklow coast between Greystones and Wicklow Town -began on Monday March 1st.

With an expected capacity of up to 1,500 megawatts (MW), Codling Wind Park has the potential to supply the equivalent of up to 1.2 million Irish homes - 70% of all Irish households - with low-carbon, locally-produced, low-cost electricity, and to save almost 2 million tonnes of carbon emissions every

Representing one of the largest energy infrastructure investments in Ireland this decade, the project will deliver substantial benefits to the regional and national economy, including more than 1,000 construc-tion jobs and 70 long-term, locally-

Due to the current Covid-19 restrictions, face-to-face engagements are not possible and so a series of online consultation activities will take place from March 1st to March 27th. In addition to a twoweek virtual exhibition, there will also be two webinars and a series of virtual information clinics to facilitate individual and small group meetings between community members and project representatives.

Further phases of consultation are planned for the summer and autumn, to share updated plans as the project progresses and provide further opportunities for feedback

The virtual exhibition will display project plans as they currently stand, including indicative photomontages from a number of viewing points along the coast. It will wcase the important role Codling will play in helping Ireland to achieve its Climate Action Plan targets and set out the wide range of benefits that will arise from the project, including for local communities, as well as the wider benefits for the regional and national economy.

Codling Wind Park Project Director, Arno Verbeek said: "We are in the early stages of planning our project and this is the first of many opportunities people will have

to see our progress and provide their feedback. Listening to and engaging with the public is an important part of our journey. We want to deliver this project in partnership with the local communities and want them to feel involved in it at every stage

"Feedback is an incredibly important part of this, and we hope that many people will take the time to view our initial plans and share their thoughts with us. This input will help us to shape and design the project in the months ahead.'

'People should also be aware of the huge potential the Community Fund will have and which will be developed alongside the development of the various wind parks due to be constructed. While details of the make-up of such a Fund are not vet drafted, now is a chance for local communities to input into what they believe should be prioritised.

"Many people and organisations will have environmental concerns regarding the construction of large scale turbines in the sea, something I am very much aware of and which I relayed to the team at our last meeting, and so I encourage environmentally conscious individuals and groups to have their say at this first phase of consultation and any forthcoming engagement with Codling Wind Park," concluded Deputy Whimore.

Council Launches 'Period Poverty' **Initiative**

Libraries and County buildings under a new initiative to tackle "period poverty."

Period poverty - loosely defined as not being able to afford to buy adequate supplies of sanitary products - is an ongoing issue and internationally, a number of countries have begun to supply products to school children free-of-charge.

Cllr Lourda Scott raised the issue at a recent Wicklow County Council meeting tabling a notice of motion that said: "Wicklow County Council notes a survey by Plan International Ireland showing that 50 per cent of Irish teenage girls find it difficult to afford period products and 61 per cent miss school as a result. Wicklow County Council acknowledges the work of organisations such as Homeless Period Ireland in collecting donated

Wicklow County Council responded to the issue by instigating a pilot scheme whereby sanitary products will be made available in the public bathrooms of each library and at County Buildings once they are back open to members of the public.

Cathaoirleach of Wicklow County Council, Cllr Pat Kennedy, raised the members of Community Cultural and Social Development section of Wicklow County Council for pursuing the pilot project and wished them every success with their endeavour.

Chief Executive of Wicklow County Council, Frank Curran. welcomed the initiative and highlighted the importance of the sanitary products and distributing to libraries playing a central role in

Cllr Scott said: "Period products are an everyday item that should be available free-of-charge like toilet paper. Being unable to buy these products every month affects people's health, dignity and education and has been highlighted even more during Covid. There also still remains a stigma associated with periods and providing products in public buildings will go far to break this down, reminding people that this is a normal part of life.

"I'm delighted that Wicklow County Council has agreed to take positive action. This signals an important step on the way in restoring support and dignity to those who need it and reducing the shame around men-

Funding for adult learners

Minister Simon Harris recently announced three projects in Wicklow will receive funding to help support education for adult learners.

They are; Vale of Avoca Men's Shed - Enhancing Members Lives; Bray Family Resource and Development Project CLG - New Ways of Learning; Wicklow Travellers Group - Funding for IT training and upskilling of Staff.

The funding to increase the participation of disadvantaged learners, particularly with the digital infrastructure including providing devices and software, and increasing their capacity to deliver online

Speaking about the funding Minister Harris said: "We know that too many people in Ireland have difficulties with reading, with numbers or with digital skills. Some people may not have got the help they needed earlier in their lives, but what I want people to know is that there is friendly and non-judgemental help there for you now. There are services all over Ireland which will gladly assist you with the skills you'd like to learn.

"One of the things that the COVID-19 pandemic highlighted was educational inequality - be it a lack of devices like laptops or someone not having the connectivity to study online. The funding I am announcing today is specifically designed to tackle those inequalities and support access to community

"Education is for everyone, for all your life, and I am determined that my department will be part of building an inclusive Ireland where nobody is left

The fund is aimed at supporting and engaging with disadvantaged learners, reaching out, encouaging and supporting learners to re-engage with education and training and attracting new learners to engage with education and training opportunities.

Crucially, it aims at helping build the digital infrastructure of providers, and their capability to ensure that online learning can be delivered in a way that meets the complex needs of all learners.

Grant funding of €4.64m was administered by Wicklow County Council's Community, **Cultural & Social Development Directorate** in 2020.

Wicklow did exceptionally well under the various Town & Village enhancement schemes in 2020, securing funding of €961,538 for 25 different projects spread across the county.

The Council's own Community Grants scheme paid out €200,000 to 300 groups while the Community Enhancement Programme saw €212,205 awarded to

163 different groups.
The 2020 Outdoor Recreation Infrastructure Scheme delivered €158,247 to nine prodelivered jects under Measure 1 initiatives. Additional grant aid is expected under Measures 2 and 3.

The latest round of Rural Regeneration Development funding saw €2.67m allocated to regenerate the town of Baltinglass.

In the sports area, €41,000 was paid out to sporting clubs and initiatives in 2020 while €73,900 was allocated to Creative Ireland projects.

Under the Healthy Ireland initiative, €115,385 was allocated for Wicklow projects while Libraries received €145.619 specifically for COVID-19 expendi-

Residents talk about their lives during lockdown and the joy the vaccine brought, suddenly they feel safer and see a very positive future. Visits from family are so much closer now and they can begin to look forward to hugging their grandchildren again.

The podcasts also tell the stories of the care teams and the difficulties they encountered in keeping the residents safe and their own fears as they fought to stay Covid-free themselves.

There are nurses and carers who tell how they spent their days in heavy protective gear and who spent their evenings at a safe distance from their own families. Frank and honest, there were bad days and frightening days but the advent of a vaccine has changed every-

But, most of all, this is a unique insight into the men and women who have made these care homes their own homes. They remember the lives they led as farmers, shopkeepers and tell golden stories from long ago. These are the people who made Ireland what it is today and who saw the nation thrive, people who raised families and who lived through tough times and survived.

They have now progressed to an active retirement and many of them are anxious to start going out into the community again.

"I think what really came across was how the residents see themselves as part of the local community and indeed many of them are living in the communities where they lived all their lives. And that community respects and appreciates their involvement and the interesting lives they have led. For many of them, Covid although unique, was just another challenge for people who have seen pretty much everything that life can throw at them," says Valerie Cox.





The environmental awards recognise best practice projects in a range of topics covering Climate Action, biodiversity, protection of resources and prevention of waste. Prize winners included Tidy Towns groups, schools and businesses.

While the national Tidy Town Competition was postponed in 2020, groups throughout the county remained active, caring for our towns and local environment and delivering new projects on sustainability and biodiversity.

It was a challenge for communities in Wicklow to keep projects going when COVID-19 restrictions limited opportunities to work together.

Many projects had to stop and preparations for the summer Tidy Towns campaign were temporarily halted. Groups went online to organise their work, often working individually on projects and coming together to carry out planned projects out-doors when easing of restrictions allowed.

With more people out and about in their local communities over the last year, this led to many new volunteers requesting litter clean-up materials, revamping green areas on estates or undertaking a project to protect local biodiversity.

All of the 29 Tidy Towns groups continued to work with local businesses to present main streets and town centres at their best.

Hollywood, Dunlavin and Greystones were judged best in county during the summer. Litter management was excellent, planted areas well maintained and shopfronts had clearly received some attention and work done during lockdown

Cll Pat Kennedy, Cathaoirleach of Wicklow County Council, congratulated the Tidy Towns groups and other award winners thanking all who gave their time to care for their communities in 2020 and who have contributed to projects that build a more sustainable future for all of us.

THREE MONTH WAIVER OF COMMERCIAL RATES

On 30 December 2020 the Government announced Level 5 restrictions including the closure of non-essential businesses from close of business on 31 December until 31 January 2021. Further restrictions were announced on 6 January 2021. To reflect these restrictions and to continue the supports available for ratepayers, and in recognition of the impact of the ongoing trajectory of COVID 19, a further waiver of commercial rates will apply to Specified Businesses in the first quarter of 2021. This 3-month waiver has modified criteria and accordingly is a separate, standalone waiver scheme to the previous 2020 scheme

There is no application process required for this scheme. Wicklow County Council will automatically apply a 100% credit in lieu of commercial rates, for a 3-month period, to eligible classes and categories of occupied rateable property where the occupying business falls under the broad headings outlined below.

- Hospitality
- Miscellaneous entertainment
- Essential retail (excluding large Supermarkets, great than 500M2)
- Service Stations
- Childcare

- Leisure including sports clubs
- Non essential retail (shops and warehouse)
- Airports
- Health
- Personal Care
- Post office

The credit does not apply to the following Excluded Categories:

- Public Service
- Vacant Properties (all vacant property as is ordinarily understood for rates is excluded from the waiver)
- Global Utility Networks on the Central Valuation List
- Properties in the "Office" Valuation Category
- Properties in the "Industrial Uses" Valuation Category
- Properties in the "Miscellaneous" Valuation Category
- Properties in the "Minerals" Valuation Category
- · Properties in the "Utility" Valuation Category
- Supermarkets greater than 500M2 (Categories Supermarket 2 and Supermarket 3)
- Properties with the valuation category of "Department Store" but which are occupied either partially or wholly by a supermarket which sells food and/or
- Banks, Building Societies and Credit Unions
- Pharmaceutical manufacturing
- Premises contracted to provide services related to the COVID 19 pandemic to/on behalf of the State, where the State is already compensating for rates as part of the contract between the occupier or service provider and the State.

The closing date for making these applications is 16th April 2021.

Please note that appeals and application of the waiver to public sector properties and vacant properties are not permitted under this scheme.

SPREADING OF ORGANIC OR CHEMICAL FERTILIZERS ON LAND

Wicklow County Council wish to remind farmers of the precautions to take when spreading organic or chemical fertilizers on to land in order to protect the quality of our drinking water supplies and watercourses.

Organic and chemical fertilisers or soiled water shall not be applied to land in any of the following circumstances -

- · the land is waterlogged;
- the land is flooded or likely to flood;
- the land is snow-covered or frozen;
- heavy rain is forecast within 48 hours, or
- the ground slopes steeply and there is a risk of water pollution having regard to factors such as surface runoff pathways, the presence of land drains, the absence of hedgerows to mitigate surface flow, soil condition and ground cover.

Please check the weather forecast as issued by Met Eireann in advance of spreading

Check for the presence of nearby sources of water supplies and do not spread within the buffer distances as outlined below
