Ireland's two largest homebuilders, Cairn Homes and Glenveagh Properties applied to the High Court last week (27th October) to seek a Judicial Review of the new Wicklow County Development Plan. They say their decision to seek a Judicial in the county at 8,467.

Review is due to the significant reduction in the number of new homes which can be built during the six-year duration of the new Plan:

"This reduction arises from a reliance on outof-date Census 2016 data instead of this year's Census and as a consequence, the Plan has materially underestimated Wicklow's population growth.

# Shave or dye fundraiser for two year old Aidan

A GoFundMe campaign has been set up by Wicklow woman Taragh Keogh, who along with members of the Pilgrims Food Masters, Shillelagh will be taking part in a Shave or Dye Fundraiser to help two year old Aidan and his family.

Aidan is a happy, bubbly two year old boy who has four older siblings. From birth Aidan has suffered chronic gut dysmotility that saw him spend his first year of life very sick in Crumlin Children's Hospital where he suffered daily from excruciating pain and vomiting.

At 8 months old, Aidan's parents were told that their son had intestinal failure and in order for Aidan to survive he would need to stay on intravenous nutrition that is delivered through a central vein line directly to his heart via his blood stream. # **Council preparing CPO for Cliff Walk**

Wicklow County Council is now preparing a Compulsory Purchase Order (CPO) which may be needed to facilitate the reopening of the closed section of the Bray to Greystones


Cllr Stephen Stokes again raised the issue of the Cliff Walk at the monthly meeting of the Greystones Municipal District on Tuesday, October 25th. He welcomed the more direct approach that Wicklow County Council is preparing.

A small section on the Greystones side is currently closed. Wicklow County Council wishes to move this particular section further inland. Wicklow County Council's Legal Team have been negotiating access over a protracted period. Cllr Stokes stated: "Wicklow County Council has not been able to make a breakthrough in negotiations with the landowner so far. This is still the preferred option of course. However the big update is that Wicklow County Council is now preparing a compulsory purchase order, if needed.

During the discussions at the October District meeting, Town Manager Michael Nicholson advised that the funding to do work has a deadline. towards the end of 2023. Cllr Stephen Stokes added: "This is a time sensitive matter. Not only is there a funding deadline, but we do not want to miss another spring/summer season. In fairness I believe that the Wicklow County Council Officials are keen to see this matter resolved as a priority. So they are now about to draw up maps in case they need to pursue a CPO.

Cllr Stokes remarked that getting the Cliff Walk fully reopened is of great importance. He concluded: "The Cliff Walk is vital as it provides a wonderful and healthy amenity for communities in North Wicklow, Additionally it brings in vital tourism to

Deputy Whitmore called on Minister Donnelly to immediately intervene and prevent any further unnecessary suffering for Miley.

"Her spine has over 100-degree curvature,

"The Minister has received the same letters as I have from Miley's parents, who have revealed she is in constant pain and is profoundly disabled. They have described her treatment by the State as child abuse and it is hard to disagree with them.

"To have Miley linger on a waiting list for any longer would be unforgiveable and a stain on our health service. Children like Miley deserve access to timely scoliosis treatment. The effort and resources invested in getting her to

# 'Putting lipstick on a pig cannot hide the lack of political priority to refurbish Wicklow Courthouse'

Sinn Fein TD John Brady has criticised the failure of the government to act and provide the necessary funding for the refurbishment of the former District Court in Wicklow Town.

The courthouse has been in a state of dereliction and disrepair since it was closed on health and safety grounds in 2010. Following questioning again by Deputy Brady, Minister for Justice Helen McEntee again confirmed that there are plans for a four-courtroom courthouse for Wicklow Town. This will involve extending and refurbishing the existing courthouse, but has been superseded in priority by plans to open another courthouse in Dublin, the new Family complex Hammond Lane and no commencement date has been given for Wicklow

Deputy Brady said "While I welcome the confirmation by the Minister that there are plans to refurbish and extend the Wicklow Town Courthouse, the reality is that Wicklow Town has been waiting since 2010 to see the refurbishment work carried out on the courthouse. It is deeply disappointing that the necrefurbishment works have again been pushed down the road. I

# COUNTY WICKLOW RESIDENTIAL ZONED LAND TAX (RZLT)

A new tax to activate land for residential purposes was introduced by the Department of Finance and the Revenue Commissioners in conjunction with the Department of Housing, Local Government and Heritage as Section 80 of the Finance Act 2021. The tax measure is aimed at incentivising residential development rather than generating revenue for the State.

In order to implement this new tax measure, local authorities are required to undertake mapping to identify the lands in scope for the tax in their respective functional areas, with provisions allowing those landowners identified as being within the scope to challenge this decision by making submissions to the local authority or, where the challenge to the local authority is unsuccessful, An Bord Pleanála. Thereafter, the administration of the tax measure will be undertaken by the Revenue Commissioners.

A draft map for County Wicklow, prepared under Section 653C of the Taxes Consolidation Act 1997, will be published on **01 November 2022** on the Wicklow County Council website <a href="https://www.wicklow.ie/Living/Services/Planning/Residential-Zoned-Land-Tax">https://www.wicklow.ie/Living/Services/Planning/Residential-Zoned-Land-Tax</a> and will be available for inspection at the Planning Department in Wicklow County Council HQ, Wicklow Town from **01 November 2022** 

The draft map has been prepared for the purposes of identifying land that satisfies the relevant criteria and is to be subject to the residential zoned land tax.

Residential properties, notwithstanding that they may be included on the draft map, shall not be chargeable to the residential zoned land tax.

Land which satisfies the relevant criteria is a reference to land that -

- (a) is included in a development plan, in accordance with section 10(2) (a) of the Act of 2000, or local area plan, in accordance with section 19(2)(a) of the Act of 2000, zoned
  - i. solely or primarily for residential use, or
  - i. for a mixture of uses, including residential use,
- (b) it is reasonable to consider may have access, or be connected, to public infrastructure and facilities, including roads and footpaths, public lighting, foul sewer drainage, surface water drainage and water supply, necessary for dwellings to be developed and with sufficient service capacity available for such development, and
- (c) it is reasonable to consider is not affected, in terms of its physical condition, by matters to a sufficient extent to preclude the provision of dwellings, including contamination or the presence of known archaeological or historic remains, but which is not land
  - i. that is referred to in paragraph (a)(i) and, having regard only to development (within the meaning of the Act of 2000) which is not unauthorised development (within the meaning of the Act of 2000), is in use as premises, in which a trade or profession is being carried on, that is liable to commercial rates, that it is reasonable to consider is being used to provides services to residents of adjacent residential areas,
  - ii. that is referred to in paragraph (a)(ii), unless it is reasonable to consider that the land is vacant or idle,
  - iii. that it is reasonable to consider is required for, or is integral to, occupation by -
    - (I) social, community or governmental infrastructure and facilities, including infrastructure and facilities used for the purposes of public administration or the provision of education or healthcare,
    - (II) transport facilities and infrastructure,
    - (III) energy infrastructure and facilities,
    - (IV) telecommunications infrastructure and facilities,
    - (V) water and wastewater infrastructure and facilities,
    - (VI) waste management and disposal infrastructure, or
    - (VII) recreational infrastructure, including sports facilities and playgrounds,
  - iv. that is subject to a statutory designation that may preclude development, or
  - v. on which the derelict sites levy is payable in accordance with the Derelict Sites Act 1990.

Submissions on the draft map may be made in writing to the local authority concerned not later than 1 January 2023, regarding –

- i. either the inclusion in or exclusion from the final map of specific sites, or
- ii. the date on which a site first satisfied the relevant criteria.

Publication of the draft maps provides a key opportunity for landowners and members of the public to participate in the process. Submissions should be restricted to setting out and providing information establishing to the satisfaction of the local authority, why the land does or does not meet the qualifying criteria set out in section 653B of the Act.

Relevant issues to be considered may relate to lands not being connected to or being unable to be connected to services, being occupied by a particular use which benefits from an exclusion or being subject to criteria such as contamination which could warrant exclusion.

Matters which are unrelated to the criteria identified in section 653B such as planning permission, commencement on land in-scope, finance, or personal circumstances are not matters that can be taken into account during consideration of submissions. Furthermore the size of the landholding, ownership of the land by private, public or semi-state bodies, lack of knowledge of ownership or transfer of ownership cannot be considered.

Submissions regarding removing an existing permanently-occupied house from the maps will not be considered, as residential premises will not be liable for the tax under the terms of the legislation.

Submissions should include a name and address, reasons for inclusion or exclusion of lands, along with a map of scale 1:1,000 (urban area) or 1:2,500 (rural area) where the submission is made by a landowner, clearly identifying the area of land subject of the submission.

Any such written submissions received by 1 January 2023 other than such elements of a submission which may constitute personal data, shall be published on the website maintained by the local authority concerned not later than 11 January 2023.

Where land identified on the draft map is included in a development plan or local area plan in accordance with section 10(2)(a) or 19(2)(a) of the Act of 2000 zoned –

- i. solely or primarily for residential use, or
- ii. for a mixture of uses, including residential use,

Where land is identified on the draft map as being subject to the residential zoned land tax, a person may, in respect of land that such a person owns, make a submission to the local authority requesting a variation of the zoning of that land. Any such submission should include evidence of ownership, detailed reasons for any rezoning request, along with a map to a scale of 1:1,000 (urban) or 1:2,500 (rural) clearly identifying the relevant plot of land.

All rezoning requests made will be considered by the Local Authority having regard to the proper planning and sustainable development of the area.

A total of 36 affordable homes, consisting of 12 two bedroom houses, and 24 three bedroom houses are being made available for sale by Wicklow County Council in the residential development of Greenhill Road, Wicklow under affordable dwelling purchase arrangements in accordance with the Affordable Housing Act 2021 and associated Affordable Housing Regulations.

The houses are available for purchase by first time buyers who do not own or have a legal interest in a dwelling, with some exceptions applicable. The dwellings will be sold at a price that is lower than market value, such price to be determined in accordance with the income of the purchaser. The minimum prices to be paid by eligible purchasers for dwellings are detailed in the table below.

All purchasers will sign up to an 'Affordable Dwelling Purchase Arrangement' with Wicklow County Council. Wicklow County Council will retain an 'Equity Share' in the

'The difference between the open market value of the dwelling and the Purchase Price paid by successful applicants' expressed as a percentage of the Open Market Value of

Wicklow County Council may not seek realisation of this Equity Share for a 40-year period (with exception where a breach of the agreement occurs). However, successful affordable purchasers can choose to redeem or purchase the Equity Share in the dwelling at any time by means of one or a series of payments to Wicklow County Council.

To be eligible to apply for the scheme, applicants must satisfy the following criteria:

- 1. Be a First-Time Buyer or meet the exceptions under the Fresh Start Principle.
- Each person included in the application must have the right to reside indefinitely in the State
- The affordable home must be the household's normal place of residence.
- Applicant's purchasing power must not exceed 95% of the market value of

Notice is hereby given under Section 31 (7) of the Planning and Development Act 2000 (as amended) that the Minister of State at the Department of the Housing, Local Government and Heritage has issued a **Draft Ministerial Direction** regarding the Wicklow County Development Plan 2022 - 2028 to Wicklow County Council as follows:

"Development Plan" means the Wicklow County Development Plan 2022 – 2028 "Planning Authority" means Wicklow County Council

WHEREAS the powers and duties of the Minister for Housing, Local Government and Heritage under the Planning and Development Act 2000 (as amended) ("the Act"), other than the power to prosecute an offence, have been delegated to the Minister of State at the Department of Housing, Local Government and Heritage pursuant to the Housing, Local Government and Heritage (Delegation of Ministerial Functions) Order 2020 (S.I. 559 of 2020).

WHEREAS the Minister of State at the Department of the Housing, Local Government and Heritage in exercise of the powers conferred on him by section 31 of the Act, and consequent to a recommendation made to him by the Office of the Planning Regulator under section 31AM(8) of the Act hereby directs as follows:

- (1) This Direction may be cited as the Planning and Development (Wicklow County Development Plan 2022 2028) Direction 2022.
- (2) The Planning Authority is hereby directed to take the following steps with regard to the Development Plan:
  - (a) Reinstate the following settlement boundaries and zoning objectives to that of the draft Plan:
    - (i) Amendment V1 11(a) (Kilpedder Willowgrove), i.e. the settlement boundary reverts to the draft Plan.
    - (ii) Amendment V1 13 (Johnstown) i.e. the settlement boundary reverts to the draft Plan.
    - (iii) Amendment V2 99 (Ashford) i.e. the settlement boundary reverts to the draft Plan and the subject land reverts to unzoned from RN- New Residential.
    - (iv) Amendment V2 103 (Carnew) i.e. the settlement boundary reverts to the draft Plan and the subject land reverts to unzoned from RN- New Residential and OS1 Open Space.
  - (b) Delete the following zoning objectives from the settlement zoning map for Aughrim:
    - (i) R2.5 New Residential (Low Density)
    - (ii) AUG 4
  - (c) Delete both Objective CPO7.xx inserted under Amendment V1-31 and associated Map 7.01:

To provide for a new nursing home/ residential care facility for the elderly at location shown on Map 7.01

• Kilmullen, Newcastle (c.2ha)

#### STATEMENT OF REASONS

#### I. Pursuant to section 31(1)(b), section 31(1)(ba)(i) and section 31(1)(c)

The Development Plan as made includes material amendments to the draft Plan, that individually and cumulatively are not consistent with the Core Strategy, national and regional planning policy, and the proper planning and sustainable development of the area, including:

- (a) Land zoned for residential development in the Level 5 settlements of Ashford, Carnew and Aughrim inconsistent with Core Strategy housing supply targets and settlement hierarchy for Wicklow County in the adopted Plan
- (b) Settlement boundary extensions and land zoned for residential development (including for a nursing home / residential care facility) located in peripheral locations removed from the existing settlement, and in the absence of infrastructure required for such development, inconsistent with the requirements for compact growth in NPO 3c and RPO 3.2, the tiered approach to zoning in NPO 72, the proportionate growth of rural towns in NPO 18(a), and the sequential approach to development having regard to the policy and objective of the Development Plans Guidelines for Planning Authorities (2022) regarding the sequential approach (section 6.2.3).
- (c) Land zoned for a nursing home / residential care facility in a peripheral and non-sequential location outside of any settlement boundary, and remote from services and amenities, inconsistent with objective CPO 6.32 of the Development Plan in relation to housing for the elderly.
- (d) Settlement boundary extensions and land zoned for development in locations that would facilitate a pattern of car dependent development inconsistent with objectives to promote sustainable settlement and transportation strategies.

The development plan as made therefore fails to set out an overall strategy for the proper planning and sustainable development of the area.

#### II. Pursuant to section 31(1)(a)(i)(II) and section 31(1)(a)(ii)(II)

The Development Plan has not been made in a manner consistent with and has failed to implement the recommendations of the Office of the Planning Regulator under Section 31 AM.

#### III. Pursuant to section 31(1)(b

In light of the matters set out at I to II above, the Minister is of the opinion that the Development Plan fails to set out an overall strategy for the proper planning and sustainable development of the area.

#### IV. Pursuant to section 31(1)(c)

In light of the matters set out at I to III, above, the Development Plan is not in compliance with the requirements of the Act.



# 'No Mere Irish' -The Kennedys of **Mount Kennedy**



lanch her new history book on the Kennedys of Newtownmountkennedy, in the Parkview Hotel at 6:30pm.

The seventeenth century in Ireland was a time of huge change. At its beginning, there were still significant areas under Catholic Gaelic ownership and cultural sway; by the end -almost none. The story of how the island made this journey is not well known.

This Kennedy family provides us with a window into a turbulent century. They were one of the few Gaelic lines who not only became thoroughly anglicized, but who went that one step further and embraced Protestantism. Their story shows how this accelerated their rise to power and improved their social standing as they became lords of a manor and baronets.

Yet despite their adroit manoeuvring, the instability of the times eventually led to their undoing.

Hicks' book 'No Mere Irish - The Kennedys of Mount Kennedy', will be of interest to those who live in Newtownmountkennedy and the surrounding communities in Co Wicklow, but also to anyone who is interested in Irish history. When told from a family's own experience, history comes alive.

Therese Hicks, originally from the United States, has

lived in Newtownmountkennedy for the past 20 years. After retiring from the HSE as a psychotherapist in 2014, she returned to her earlier interest in history, and began to look into the local history of her current home. # Wicklow referee assault recalled in new book

John Scally's new book 100 Great GAA Controversies recalls one of the most controversial episodes in Wicklow football. Scally writes:

The greatest champion of referees I ever met was John B. Keane. He soared into a near operatic standard of storytelling to make the case for them to me:

There is a daring breed of men whose exploits never make the front pages of newspapers, whose heroics forever remain unsung, whose visages will never be seen on our television screens and about whom no songs are made. Be that as it may, what matters is that this breed of men is common to every generation and no matter what abuses or tortures the breed suffered in a previous generation, it will always bob to the surface in this present one. It will show itself to be unsullied and untainted by previous wrongs and it will carry on with the job regardless.

'I refer, of course, as if you didn't know, to that dauntless band of gentlemen, none other than those heroes who referee junior football matches. Now don't get me wrong. There are few of us who loved the game who did not at one time or another find ourselves with a whistle in the hand when the appointed referee failed to turn up. This is all very well but, while we may have acted the part once, nothing on this earth could induce us to do so again. We did it and we wrote it down to experience. We were grateful to escape without injury and those who suffered physically were even more resolved never to be caught gain with a whistle in the hand.

The hero to whom I refer is he who comes out Sunday after Sunday to do the needful in the matter of refereeing. Often his task is easy and pleasant but only when one team is so much better than another that a referee is not needed at all. His life is in danger however when there is nothing between the teams. Then, in the eyes of the partisans, his every decision is riddled with prejudice and no matter what way he points the finger he is greeted with a storm of catcalls and booing. To these he is impervious and he takes them for granted. It is when he makes the genuine mistake that he is in serious trouble. Nothing will convince the injured party but that it was deliberate. First the ball is flung at the referee. Then he is abused with a wide range of choice epithets.

'The best I heard of came at a junior semi-final. All vent well and our friend staggered around without falling. What saved him was the fact that he did not blow the whistle. Then following a long bout of booing he blew and having blown he could not remember why. The pitch

was invaded but, completely in command, our friend raised his hand and announced that he had blown the whistle in order that two minutes silence might be observed. Nobody asked who was dead. It wouldn't do to exhibit such ignorance.'

While John B. created humour out of these situations he also recognised that there were times when it was anything but funny. Tipperary-based referee Willie Barrett was struck on the back with a hurley in 2010 by a supporter.


#### Down Wicklow Way

In 1985 Johnny Price made national headlines following Blessington's one-point win over Annacurra in the Wicklow under 21 B football final in Baltinglass. Price, walked to his car to change and get ready for his journey home to Roundwood from Baltinglass. His youngest son, David, was seated in the front seat when he heard a loud noise, the sound of the car's rear door slamming shut. During the game his father had sent off a player from Annacurra and while he was changing afterwards three men approached him and shouted abuse at him, before one forced him inside the car. Reports in the local media claim that it took the intervention of the county vicechairman Liam O'Loughlin and Baltinglass secretary. Garda Seamus Kelly, to rescue Price from the boot of his

A week earlier in Arklow, Price had suffered a severe assault in the course of a league match between Aughrim and Barndarrig which left him out cold for a short time. He was punched twice and kicked in the ribs while on the ground. Showing remarkable physical and moral courage Price got to his feet finished refereeing the match.

However, the story of a referee locked in the boot of his car created a media sensation. The Annacurra fan who attacked Price at his car was banned for life by the GAA. Mr Price died in 2005.
